

Economic Development

- Skywalk approvals were completed in October 2019 and construction began in November 2019 with a proposed opening date of March 2021
- Business Park concept was finalized and work began with completion of phase 1 set for Fall 2020
- Marina and Boat Launch concept was developed with funding from Natural Resources Canada
- Indigenous Bloom store opened in April 2020 creating 10 jobs for members
- Malahat Nelson Environmental partnership took over the fill site from Quantum Murray
- Malahat Studios concept has continued to advance with the expectation that feasibility will start in the coming year





Environment and Fisheries


- Planned and implemented programs to actively improve the environment and increase species populations which are environmentally and culturally important
- Enforcing fisheries violations, removing derelict marine equipment from the Saanich Inlet
- Ensuring future generations have robust affirmation of their rights and title as defined by Douglas Treaty & Modern Treaty and removing barriers to exercising these rights, especially in the marine environment (boat launch, marine training and safety equipment)
- Increased Malahat presence on the water to assert Malahat's rights and title in the marine territory through documenting past use, facilitating present use, and planning for future use
- 12 Malahat members graduated from Community Entrepreneurship training program through Work BC in partnership with UVIC





Lands

- Defended Malahat's groundwater rights from the Province
- Protected Malahat's future treaty lands from outside interests
- Protected Malahat's aboriginal forestry interests with the Province
- Just a few examples of more than 120 consultation requests related to Malahat's interests
- Drafted Cannabis control law to protect Malahat Nation and bring jobs and income to Malahat













Community Programs & Kids' Education

- Cultivated the community gardens
- Ran the Social Assistance program to benefit Malahat members
- Ran the "couples program," parent and tot play group, kids programs, fitness groups, and many more
- Brought traditional cultural activities to community programs
- Worked with local schools to support Malahat students and bring cultural events to the schools





Health Programs

- Coordinated medical and dental appointments and health planning for children, families, and elders
- Provided counselling and referrals as well as support groups
- Ran the Elders Luncheon, good food boxes, weekly elders' day out, and more programs for elders
- Created Cultural Tuesdays videos to share Malahat culture with the greater community





Early Childhood Education

- The Aboriginal Head Start Program and any programming for children under 5 was transitioned to the Early Learning department from Community Programs and an additional ECE was hired to help facilitate
- Daycare build and outdoor playground space completed and furnished in March 2020
- The licensing process was started, so that Malahat kids can go to a licensed childcare facility





Post-Secondary

- Malahat students spent our full financial allotment for the first time in years and we now have a waitlist so no money was sent back to the federal government
- Created a standard living allowance to provide a fair amount for our students
- Established living allowance support for part time and upgrading students







Housing Administration

- Streamlined housing to bring the community faster repairs and better communication through a formalized repair and complaint system
- Completed construction of two 3 bed and 4 bed duplexes
- Developed housing policy for 2020-21
- Making progress on the 8 plex construction of 8 new 2 bed, 1 bath units anticipated to be completed by end of 2020





Community Infrastructure

- Completed the Community Infrastructure Services Plan to support the ongoing management of assets and services for the community's infrastructure
- Began planning of Malahat Nation Water System and prepared for submission with the support of Urban Systems
- Created full time salaried positions for 5 Nation members creating work crews based to support both infrastructure and community housing services
- Completed construction on the Health Unit, Daycare and Recreation Center














Communications


- Overhauled Malahat Nation website from the ground up so it can be easily modified over time to serve community and administrative needs
- Dramatically increased Facebook presence and created the Malahat Community Group to provide a forum for members and to share content with the community
- Malahat News delivered to membership every two months and developed a mailing list to ensure it reaches as many members as possible





Treaty

- Consulted with community through Open Houses, Community Meetings, Land Tours, Family Dinners and Presentations at community events
- Significant progress made on the draft Malahat Constitution.
- Negotiated the forgiveness of all negotiation support loans. This amounts to millions of dollars that we no longer have to pay back
- Worked with the Province to support the passage of legislation formally adopting the principles of the UN Declaration on the Rights of Indigenous People.
- Organized a weekend-long Youth Summit at Bear Mountain for youth representatives from the different TTA Nations to help them learn more about the treaty process.





Governance & Administration

Governance

- Began comprehensive overhaul of Malahat law and policy to modernize our government and bring transparency between the government and the community

Financial Administration

- Dramatically overhauled and began to repair Malahat's finances
- Created proper budget, the first Council-approved budget in years
- Improved and developed internal controls to ensure all Malahat Nation money is protected and accounted for
- Audit was completed on time, Financial Statements and Special Purpose Reports are available in the band office for review and online at malahatnation.com/about/governance/reporting
- Financial Administrative Law and Policies have also been made available on malahatnation.com
